## KANSAS CHAPTER KICKS OFF FALL SEMESTER

Delta Upsilon opened the doors of 1025 Emery Road this fall to a strong pledge class, a solid group of upperclassmen, a new housemother, new cook, and a host of summertime property improvements.

The alumni board is proud of undergraduates **Brian Huntington '08**, **Joe Coletta '08**, and **Mark Robinson '08**. Brian was named Delta Upsilon International's Undergraduate of the Year at this summer's convention. He received this award because of the significant, positive impact his leadership had on our Chapter. He received a \$1,500 grant and his name will be engraved on a plaque hung permanently at Delta Upsilon's headquarters. Joe received the highly sought after Oak Circle Scholarship, and Mark received the prestigious McQuaid Scholarship. Each award recognized their strong academic performances and noteworthy leadership in the Kansas Chapter. To have three great young men from our Chapter virtually sweep some of the most significant International Fraternity awards speaks well for the kind of men recruited by our Kansas Chapter.

The Alumni Corporation Board invested significant funds in the repair and replacement of windows and windowsills in the Chapter House this summer. The window work was important to the long-term maintenance of our house. It was accomplished with no interruption of the architectural appearance of the property. Wireless Internet routers were installed so our young academics could have access to Internet resources wherever they may be studying.

## Kansas Chapter Remembers Loyal Brother *Norman Smith '47*

Brother **Norm Smith** of Tacoma, Washington, died June 11, 2007, after a short illness. He was 91. Norm was born in Elkhart, Kansas, in 1916 and attended KU in the 1940s. He earned a B.S. in business, but his military career diverted him to command a civilian conservation corps in the Black Hills of South Dakota. His service in the military included stints in the Army Coast Artillery, the Western Defense Command at Fort Lewis, the Allied Forces Headquarters, and later with the Allied Commission in Italy. Following active duty, he served as a reserve Lt. colonel in the Adjutant General Corps.

He and his wife, Lillian, were married in 1946 and they purchased a men's clothing store in downtown

Tacoma, which they operated for 36 years. A savvy investor and avid sailor, Norm served as commodore of the Tacoma Yacht Club. Civic and charitable work was also an important part of his life, especially Kiwanis work with underprivileged children. Norm and Lil enjoyed many retirement years of travel and leisure, spending winters at their home in Hawaii. She preceded him in death in 2000.

Norm considered himself a lifelong DU and was very generous to our Chapter through the years. He was honored as a Distinguished DU Alumnus in 2000. Norm's brother-in-law has informed the DU Educational Foundation that an estate gift is pending—a final brotherly gesture from a very fine man indeed.

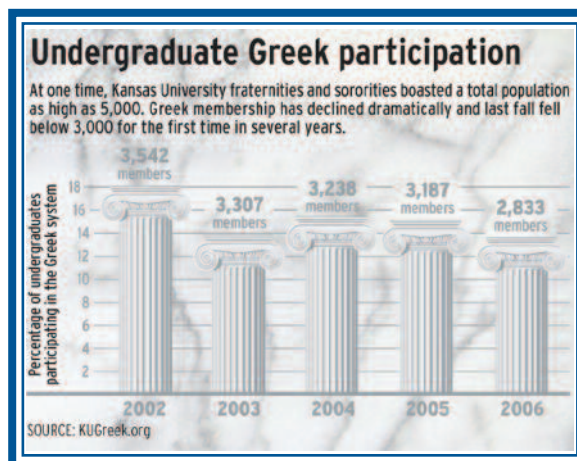
