## In Memory Housemother Shirlie Ann Vaughn 1931-2006

Our beloved DU housemother, Shirlie Vaughn, died at Kansas University Hospital on December 3, 2006, after a brief illness. Her death came as a shock to her family, as well as her DU family of undergraduates, alumni, parents, and friends. DU undergraduates kept a vigil and visited her frequently during her illness.

An overflow of friends, family, and a large contingent of Greek leaders and housemothers joined the DU Chapter at her visitation and memorial service. Members of the Chapter sang a DU song and a quartet of brothers sang "Irish Blessing" a cappella in loving tribute. Chapter members served as casket bearers as she was laid to rest in Lawrence's Oak Hill Cemetery (also the final resting place of **Lloyd Houston, Williams College 1906**). Affectionately known as "Ma Duck," Shirlie's daughter testified to the love and strength Shirlie drew from "her boys" through nearly 25 years as "mom."

Outside of DU activities, Shirlie's personal life was filled with volunteer work and weekly bridge games. She was active in the campus housemother organization and mentored new housemothers. She also taught etiquette lessons to members of other campus Greek organizations. Shirlie was a past board member of Kappa Alpha Theta Sorority and P.E.O. She was a

precinct committeewoman and served as campaign chairwoman for Larry Winn and Bob Dole. For many years, she hosted a local AM radio show, "As the Potato Peels." She also participated in occasional Bible studies at the Chapter House.

The consummate hostess, Shirlie carried herself well in any situation and was equally esteemed by parents, alumni, and campus officials. KU Chancellor Robert Hemenway said, "In her three decades of service to KU, she touched the lives of thousands of students. With great care and wisdom, Shirlie Vaughn helped guide the personal and academic lives of the young men who were in her charge."

Shirlie leaves behind son **David Vaughn '91**, daughters Sandie and Tammie, all of Lawrence, and 10 grandchildren. Two grandchildren preceded her in death. She was married for 32 years to "Arkie" Vaughn. They were divorced.

The Shirlie Vaughn Memorial Fund has been established, and proceeds will provide an annual leadership prize and/or scholarship in her honor and memory. With the unexpected passing of Mother Vaughn, the Kansas Chapter entered into a new era in its rich history. We spent the first several weeks mourning our loss and celebrating Mother Vaughn's life. She always bragged that her DU boys are "good boys." Circumstances are providing the undergraduate Chapter an opportunity to step up and prove she was right.

The Chapter House opened for the spring semester with commitments from the undergraduates to self-govern responsibly during this interim period, and from parents and alumni to faithfully support those efforts. So far, everyone has lived up to their commitment. Undergraduate officers are taking more responsibility in day-to-day operations, food service and supplies are being provided by a third-party vendor, and alumni are assisting as needed.

Presently, the House Corporation Board is assessing the needs and resources of the Chapter

as it relates to a modern-day housemother/house director position. The undergraduate members, their parents, alumni, and university personnel have each been asked to provide input to the board from their unique perspectives. Once the needs and resources have been identified, we will more clearly define our hiring objectives and proceed with a formal search.

We continue to make strides in our efforts to properly maintain the Chapter property and update it to remain competitive with other fraternities on The Hill. Quite frankly, it is a struggle given the remodeled facilities and plans that are in the works by other groups. Things like new boilers, updated fire alarm panels, replacement windows, and modified kitchen ventilation are hardly items to write home about, but each is necessary in operating the Chapter House.

Objectives for the upcoming spring and summer include working with the undergraduate Chapter to

increase the amount of study space available in the house and re-arranging a few things to make more effective use of our educational/leadership space.

The House Corporation Board also recognizes the fine leadership displayed this past year by graduating seniors **Paul Lantis '07** and **Trey Sabates '07**. As the undergraduate president and vice president, respectively, they successfully guided their undergraduate brothers and helped shape undergraduate policies that will set DU standards high in the foreseeable future. Most importantly, Paul and Trey groomed a group of bright, talented, and capable undergraduate leaders who are boldly forging ahead as we enter this new, exciting era for the Kansas Chapter.

## HONOREE: WILLIAM G. LANDESS '54

Listing the life activities of honoree Brother **Bill Landess '54** could fill an entire newsletter, so for brevity, here are a few highlights:

Brother Landess hailed from Liberal, Kansas, and was mentored at KU by the likes of **Jack Scrivner '48** and **Max Weber '47**. His undergraduate campus activities ranged from ROTC to the KU marching band. He also served as Chapter vice president and social chairman. He led an effort and organized the "welcome home" parade and festivities for the famed 1952 NCAA basketball championship team, which included a number of DU brothers.

Brother Landess received a B.S. degree in business administration from KU in 1954. After graduation, he was commissioned Second Lieutenant in the U.S. Air Force, ultimately achieving

rank of Captain in the Air Force Reserve. In 1960, he joined Merrill Lynch, where he is currently first vice president of investments and is a wealth management advisor.

Bill is a member of over a dozen organizations and has served on a diverse range of civic, charitable, and service boards, including Northwest Texas Hospital, Amarillo International Airport, Salvation Army, Amarillo Opera, West Texas A&M University Foundation, Amarillo Area Foundation, and many others.
