### DU LEADERSHIP INSTITUTE AND AWARDS

For the past five years, every DU chapter across the country has been asked to complete a comprehensive report titled the Chapter Excellence Plan (CEP). This is the major tool used by the International Fraternity to evaluate chapter operations, and to determine the status and quality of the individual chapters. This past year, the Kansas Chapter earned a score of 100.66 percent, not only the highest mark of all 83 chapters, but also the best score ever recorded by a chapter.

**Paul Gregory '05, Wes Osbourn '05, Nathan Rosemann '05, Lewis Gregory '75, and Rod Barleen '97** represented the Kansas Chapter in Norfolk, Virginia, at the 2003 Delta Upsilon Leadership Institute and Grand Awards Banquet, July 31-August 3. This group accepted awards on behalf of the chapter for Outstanding Academic Assistance, Outstanding Public Relations program, Outstanding Membership Recruitment program, Outstanding Membership Education program, Outstanding Chapter Administration, Outstanding Facility Management, and Outstanding Alumni Relations. In addition to these terrific distinctions, the Kansas Chapter was selected as a finalist for the Sweepstakes Award, the highest honor bestowed on a chapter by the fraternity.

## GIVING OPPORTUNITIES DEFINED

Report by Lewis D. Gregory '75

Brothers, the undergraduate chapter is doing a terrific job and I want to encourage you to support them with your charitable gifts. Here is a summary of ways to benefit the Kansas Chapter of Delta Upsilon Fraternity.

### KANSAS CHAPTER OF DELTA Upsilon EDUCATIONAL FOUNDATION

The purpose of the Foundation is: "To build and manage the assets of the Foundation and to make financial grants to the Alumni Corporation of the Kansas Chapter to the IRS permitted level." This financial assistance can include reduction of chapter house indebtedness and annual funding of the Foundation's permitted share of chapter house operational costs incurred. This enhances educational space and maintains all educational areas of the chapter house, including payment of maintenance, utilities, insurance, real estate taxes, and overhead costs. We are underfunding the annual request from the Corporation Board.

Typically, these gifts are part of the regularly scheduled annual solicitations by mail, capital gifts for debt reduction, special projects with targeted alumni, and estate gifts or planned gifts from alumni who have graduated more than 35 years ago.

### DELTA Upsilon LLOYD H. HOUSTON SCHOLARSHIP FUND

This fund is with the KU Endowment and was started by Brother Houston in 1957 with a contribution of \$2,500. The fund in November 1998 was \$2,230.74. No loans have been executed in more than 15 years. Initially, the fund was to be managed as a term-endowed fund. Several years ago, we changed the fund to become a permanently endowed fund maintained by the KUEA

with the income from, but not the principal of, the fund to be used as follows: to provide scholarships for deserving KU students who are members of the Kansas Chapter of Delta Upsilon Fraternity. An appropriate committee appointed by the Kansas Chapter of Delta Upsilon Educational Foundation Board thereof shall determine the amounts of such scholarship awards and recipients. To be a permanently endowed fund and make monies available it needs to be above \$10,000 by the end of 2003. We have reached this level and will be awarding about \$600 split between brothers with highest grades in the chapter. The Parents' Club also supports this gift directly. As a comparison, SigEp's fund is about \$300,000. Our competitive nature should encourage some giving!

KU First Gifts can be counted in this fund. The general solicitation for KU First will go out this fall; I encourage you to consider adding your gift to the existing fund. Or, for those wanting to start your own named scholarship or leadership fund, the minimum is \$25,000.

### THE INTERNATIONAL DELTA Upsilon EDUCATION FOUNDATION

This foundation will use monies for either the general purposes of the fraternity or specifically for projects benefiting the local chapter. Leadership training is the main focus of the conference and regional meetings. Gifts from KU alumni ensure that our undergraduates attend and also are recognized for outstanding chapter performance.

Brother Gregory serves as president of the Kansas Chapter of Delta Upsilon Educational Foundation Board, a trustee of the International Fraternity Delta Upsilon Educational Foundation Board, on the steering committee of KU First, and KU Endowment Association's \$500 million campaign, Invest in Excellence.
