Over the past few months, Kansas DU alumni and undergraduate leaders have worked together to develop a new program that we believe will better position our undergraduate members for success in college and beyond. We are excited to share a few details about this groundbreaking effort.

A primary goal of Delta Upsilon is to build better men. Members are expected to develop their skills as students and leaders and are encouraged to participate in a diverse range of campus, social, and community

activities. In addition, the communal setting of the Chapter House presents opportunities for members to refine their conflict management and self-governance skills. All of these experiences help prepare students for success after college in a unique way that cannot be matched by other living arrangements at the University of Kansas.

Each year, student leaders, campus officials, alumni volunteers, and professionals from the Delta Upsilon International Fraternity work together to help advance the

Fraternity's mission. Like most organizations, there are limits to the amount of time and resources available. As a result, the quality of the fraternal experience can vary from year to year—even in a Chapter like ours that has been on the KU campus for 88 years.

To help address this issue and to create an environment where students have more opportunities to reach their full potential, we have created a new role, the membership development advisor (MDA). The MDA will serve as a leadership resource and personal mentor for undergraduate members and help sustain a culture that reinforces the fraternity's principles. We expect the MDA to operate as a quiet, yet visible presence: building relationships by attending various Fraternity events and spending regular hours in the Chapter House.

More specifically, the MDA will emphasize academic excellence as the primary objective of our members, mentor undergraduates on leadership skills, and serve as a confidential resource on personal issues. He will advise the Chapter in recruiting and developing well-rounded members and will be available to help students better prepare for life beyond college. The MDA will underscore the importance of internships and help students prepare for job interviews and graduate school admission. While he may not have the personal expertise to assist every member, he will help the students connect with the appropriate university or alumni resource. In

Meet the New Membership Development Advisor

Joe Snyder, Delta Upsilon's new membership development advisor, has an extensive leadership background. He began his academic preparation at St. Louis University, where he received both a bachelor and master degree. He also obtained a master of theology from Jesuit School of Theology in Berkeley, a professional diploma in educational administration from Fordham University in New York, and a doctorate in education from the University of Kansas.

He began his career in education teaching mathematics as a graduate assistant. After completing his master's degree, he taught mathematics in St. Louis, and later began his administrative work as assistant principal at St. Louis University High School.

After gaining experience as assistant principal, Joe began his profession as principal in Denver, Colorado, at Regis Jesuit High School in 1979. He later became principal for Turner High School in Kansas City, Kansas, and eventually found his way to Lawrence Public Schools. He retired July 2008 as principal of Lawrence Free State High School.

Joe is a member of the Jayhawk Breakfast Rotary and the Lawrence Chamber of Commerce. He has served on a vast array of boards and is involved with many community organizations. He is married to Marilyn Page, who directs Marian Health and Dental Clinic in Topeka, Kansas. Joe and Marilyn reside in Lawrence, Kansas.

short, the MDA will help all members grow as students and fraternity men.

We are excited about the addition of this high-level program to our Chapter and we are equally excited to let you know that Dr. Joe Snyder has been hired to serve as MDA. Joe has over 40 years of teaching and high school administration experience, and he most recently served for 12 years as principal of Lawrence Free State High School (more details about Joe's background are included in his brief biography on the front page).

The MDA position has been entirely funded during its inaugural year through a generous donation of an anonymous alumnus. In the future, we anticipate that our alumni membership will collectively provide the funding required to refine and further develop the MDA position (i.e., house bills would not be impacted). We will measure the impact of the program over time, but expect a number of improvements including higher G.P.A.'s, stronger membership retention, increased alumni involvement, and an overall improvement in Chapter operations.

To underscore a very important point: the MDA will not serve as a surrogate parent, disciplinarian, or maintenance man, but rather as a resource to help students make better and more informed decisions as they advance through their undergraduate career. The MDA understands that he will have to earn the trust of undergraduate members individually, but he looks forward to being there to help them avoid pitfalls, learn from their experiences, and successfully pursue their goals. The MDA will not live in the Chapter House and his role will be complementary to those of the housemother, Chapter advisor, and Alumni Corporation board.

Kansas Chapter Earns Second-Highest Overall Chapter Score at Leadership Institute

Greetings from 1025 Emery Road! With the fall semester underway, I am excited to share with you many of the Chapter's recent accomplishments and look forward to maintaining Delta Upsilon's status as a top fraternity at KU.

DU Awarded Sweepstakes Finalist at 2008 Leadership Institute

Delta Upsilon was once again highly decorated at this summer's Delta Upsilon Leadership Institute. **Bryan Wassenberg '09**, **John Stolle '10**, **Peter Fields '10**, **Logan Brown '10**, and I attended the event in Houston, Texas. The Kansas Chapter received perfect CEP (chapter excellence plan) scores in the areas of fraternity ritual, financial management, facility management, membership recruitment, academic performance, membership education, new member education, public relations, and service. We were distinguished as Sweepstakes Finalists and earned the second-highest overall chapter score.

38 New Members Signed

The spring semester was another successful effort by our recruitment chairmen. John Stolle, Logan Brown, and **Eric McCarthy '10** signed 38 new members for the fall semester. Our freshmen were outgoing high school students, and we have high hopes for where they will lead the chapter in the future. **Mitch Knopp '10**, pledge educator, is doing a fantastic job implementing the new pledge education program.

Chapter G.P.A. Second on The Hill

The Chapter continues to excel in academic per-

formance. Last spring, we earned a Chapter G.P.A. of 3.22, placing us second on The Hill among 25 fraternal organizations. Ten of our members earned a perfect 4.0 G.P.A. and 17 of our members attained a 3.75 or higher. As high school students, our 38 freshmen had an average G.P.A. of 3.6 and we are confident they will contend for the top pledge class G.P.A. this semester. We have also set our fall scholarship dinner for October 7. All members will invite a faculty member to attend the formal meal, and alumni are welcome to join us for the dinner, which is being prepared by Chef Y'vonne.

DU Finished Third in Intramurals

Delta Upsilon finished third on The Hill in intramurals last spring. We are three-time defending intramural football champions and hope to add another trophy to the case this fall. We are also competing in Homecoming with Pi Beta Phi, our Rock Chalk Revue partner last spring. Homecoming week is October 20-25 and, after finishing second the past two years, we are confident in our likelihood to bring home the Homecoming trophy. Our Rock Chalk Revue partner this year is Kappa Alpha Theta. Our Rock Chalk directors, **Dan Torson '11**, **Zack Zastrow '11**, and **Pat Peterson '10**, hope to make it DU's fourth straight year as Rock Chalk participants.

DU High Honor Goes to Lewis D. Gregory '75

At this year's DU International Leadership Institute and Convention in Houston, Texas, our very own **Lewis D. Gregory '75** was awarded the Delta Upsilon Distinguished Alumni Award, the highest honor in Delta Upsilon. Since its inception, the honor has been bestowed on a chosen few. It is intended to recognize brothers who have shown dedication to the Fraternity through time, talent, and treasure and by "their tireless efforts, dedicated service, hands-on involvement, or unselfish financial giving."

As an undergraduate of the Kansas Chapter, Lewis served as president and recruitment chairman and was in charge of the KU interfraternity recruitment program. After graduation, he served as field secretary on the staff of DU International Fraternity. Lewis is a former DU province governor and past member of the International Fraternity's board of directors. He has served as president of the KU Alumni House Corporation and is a trustee of the Kansas University Endowment Association. He is president of the Kansas DU Educational Foundation, and in 2002 Lewis joined the foundation's international board of trustees and serves as secretary.

Only a handful of DU alumni from chapters across the United States and Canada have received this high honor, including Nobel Prize recipient **Dr. Linus Pauling, Oregon State '22**, former U.S. Attorney General **Herbert Brownell, Nebraska '24**, and legendary college football coach **Lew Holtz, Kent State '58**. The only other Kansas recipient of this high honor was the late **Keith D. Bunnell '46**, for whom the Chapter House library is named.
