## CHANGES TAKE PLACE FOR DELTA UPSILON

- ◆ *Kansas Chapter Study Hall and Leadership Suites Updated*
- ◆ *DU Rewrites Pledge Education Program*

The Alumni Corporation Board recently “cut the ribbon” on the Chapter’s new study hall and leadership suites. Financed with a grant from our Education Foundation, the area directly below the Bunnel Library underwent a \$20,000 renovation into a study hall complete with new flooring and wall covering, additional lighting, wireless Internet access, and 20 private study cubicles. The Kenneth Higdon Leadership Room was also renovated with workstations, file cabinets, and a conference table so the undergraduate leaders now have a place to conduct Chapter business.

Leaders from the undergraduate Chapter and the alumni corporation board are working together to rewrite the Chapter’s pledge education program. With the guidance of Delta Upsilon International, the Chapter’s new program will be unveiled with the fall 2008 pledge class. It will then be studied and modified before being made available for use at other Delta Upsilon chapters. Changes include less memorization,

more speakers, activities focused on DU’s four founding principles, more creative ways to teach Chapter history, and learning opportunities that pave the way for our pledges to be successful in school and in their careers. Because the program is more streamlined, initiation will now occur in October after mid-term exams. This is consistent with the current practices of several other top national fraternities.

Strong academics and Chapter involvement will continue to determine eligibility for living in the house and other membership benefits.

## Honoree: Roger M. Morrison '65

The decision to pledge Delta Upsilon was made easy for Roger. During the recruitment process, he felt at home, was treated as one of the guys, and was thrilled to be associated with men he admired so much.



Roger actually liked pledge duties; cleaning the house was a time of building friendships. His pledge father, **Bob Guenther '64**, of Wichita is still a personal inspiration and a great friend.

Roger served as song leader and was ably assisted by the piano talents of **Bob Shenk '65**. A great believer in the value of traditions, Roger says the singing of the fraternity songs, both at the house and for the sororities, was good fun.

The association with fraternity brothers gave him valuable training in social activities, study habits, and how to have fun. Roger says, "I am eternally grateful for the opportunities afforded me in the DU house and am honored and still in disbelief to receive the Distinguished Alumni Award."

After graduating with a bachelor of arts degree in English, one of the best and most significant events in his life occurred when he married Maureen "Sissy" Maloney, a Kappa from Hutchinson. They have a son and three daughters; their K-State graduate son lives and works in Salina, and their daughters—a K-State graduate and two KU graduates—are married and live in Kansas City. They have nine grandchildren.

Roger began working in the family business after graduation. The businesses of grain storage, farming, salvage, building supplies, and livestock production in the USA and overseas provided an exciting opportunity to work with some terrific associates. He is partially retired, managing personal investments, traveling with Sissy, and enjoying their grandchildren.

In his spare time, Roger serves as a trustee of endowment funds for the Salina Presbyterian Manor, St. John's Military School, and Salina YMCA. He is also the chairman of the advisory board of the McPherson College Auto Restoration Program and the Silver Ghost Association.

Roger's primary interest and hobby has been with automobiles. In 2007, his 1932 Ford Competition Roadster received the Most Significant Hot Rod at the Pebble Beach Concours d'Elegance.

Sissy and Roger have driven Rolls-Royces and Bentleys ranging from 1912 to 1929 and post-WWII sports cars on numerous tours in the United States, as well as New Zealand, the British Isles, Europe, and Canada.

## Honoree: Richard Morrison '70

**Richard Morrison '70** grew up in Salina and graduated with a B.A. degree in economics. He spent the spring semester 1968 in active duty with the Air National Guard, missing a trip to the Orange Bowl with the Jayhawk marching band. His love for music continues with a collection of hand-played drums from his travels and is exemplified by service as president of the Salina Symphony board of directors and on the board that created Salina's Stiefel Theatre for the Performing Arts from the old Fox movie palace.



Richard has been active in the Salina Chamber of Commerce, St. John's Military School board of trustees,

Salina Downtown Lions Club board of directors, the American Society of Civil Engineers standards committee on fabric structures, and is an elder of First Presbyterian Church.

He was introduced to Sallie Brower by pledge brother **Larry Scott '71**. They were married in 1971 and have two children; daughter Mindy, her husband, Jeff Gueldner, and their three daughters live in Olathe, and son Jeffrey lives in Lawrence with his wife, Mary Margaret, two sons, and twin daughters.

Richard has been active in his family's business since graduation, first as president of Thermo-Flex Inc., which manufactured pole vaulting equipment and air supported and tensile membrane buildings. His improved design of landing cushions was granted a U.S. patent. Since that company sold, he has been a business manager of Morrison Ventures, which is mainly involved in agricultural businesses.

Richard's main hobby has been collecting and racing vintage cars. He still has his first car, a 1925 Model T Ford that he drove to junior high school, and a 1967 Shelby GT350 Mustang identical to the one he had while residing at 1025 Emery Rd. He has restored and raced cars, ranging from his 1925 3-litre Bentley, to the MG Liquid Suspension Special, which he rooted for at the 1964 Indianapolis 500. He won his class at the famous Monterey Historics in a 1939 V-12 Lagonda and the 2,000+ mile La Carrera Panamericana across Mexico in a 1958 Mercedes.

## Honoree: Mark Zuercher '78



A Wichita native, **Mark Zuercher '78** was affectionately known as "Z-man" by his DU brothers. Mark graduated with a degree in business and followed that with an MBA from Southern Methodist University's Cox School of Business in Dallas. Fresh out of graduate school in 1979, Mark joined what is now Union Pacific Railroad, where he worked for the railroad's equipment group in San Francisco for six years.

Faced with the prospect of being relocated to Kansas City, Mark joined a small railcar and locomotive leasing company called Helm Financial Corporation so he could remain in the San Francisco area. Over the next 15 years, Helm Financial grew to become North America's largest privately owned rail freight equipment supplier with a fleet of nearly 1,000 locomotives and 25,000 railcars. In 2000, Mark and several partners purchased the company from its founders and in 2005 sold a majority share of the business to k1 Ventures Ltd. of Singapore. Mark remains active in the company as senior vice president of marketing but plans to take an early retirement in July 2008. Mark resides in Orinda, California, with his wife, Jane. Their son, Benjie, is a sophomore at the University of Washington, and their daughter, Hayley, is a freshman at the University of San Francisco.
