Chapter Grateful for Membership Development Advisor

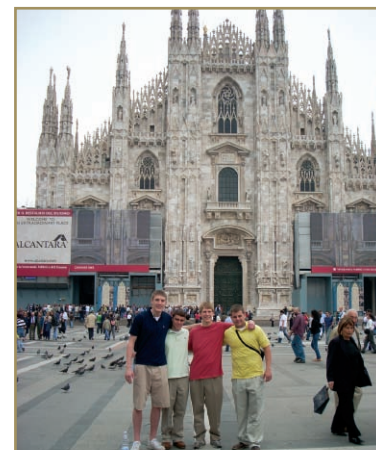

2009 DISTINGUISHED ALUMNI AWARD

Honoree: Arthur L. Ludwick Jr., M.D. '34

A previously announced \$10,000 estate gift to the Kansas DU Education Foundation from the estate of our late Brother **Arthur L. Ludwick Jr., M.D. '34** only gives us a glimpse of Lud's extraordinary loyalty. Lud passed away in February 2008 at the age of 94 and his daughter, Peggy, of Yakima, Washington, shed more light on this fine man who outlived all but a few of his contemporaries.



Lud's father died in the spring, just prior to his enrollment at KU in 1930. Within the first few months of college, he realized that as an only child, he was needed at home to assist his widowed mother. In spite of his short tenure living at the Chapter House, he remained a loyal DU until the day he died.

"As a young college freshman who was an only child, having recently lost his father, Dad was forever grateful for the camaraderie, brotherhood, and socialization opportunities that DU provided. Having upperclassmen as mentors and role models really helped shape his character at this impressionable time of his development," said Peggy, and he was especially proud that the fraternity was a non-secret organization.

Lud received his undergraduate degree in 1934 and his M.D. in 1936 from KU. He was a member of Phi Beta Pi professional medical fraternity. After internships and residency, he practiced medicine in Waterloo, Iowa, and met his wife-to-be, Jean Hoyer. In 1941, he joined the Iowa National Guard and his outfit was federalized and shipped to serve in WWII following the bombing of Pearl Harbor. Lud served in North Africa and Italy as a surgeon on the front in 14 major battles. He was awarded with both the Silver Star for gallantry in action and the Purple Heart. Lud was discharged from duty in 1946.

Before his retirement in 1988, Lud practiced family medicine, including obstetrics and surgery, for 51 years at Washington State University. He was a member of the American Academy of Family Physicians and served in various leadership positions. Lud was involved in professional organizations, his church, Rotary, and the Masons. He is survived by Jean, his wife of 67 years, daughter Peggy, and son Jack.

Peggy mentioned that later in his life Lud visited KU and the DU Chapter House, locating the engraved brick he purchased for the courtyard during the renovation and capital campaign. She remarked at how pleased he was to have a photograph standing next to that brick representing his years of association with Delta Upsilon.

For his gallant military service, his long and distinguished career as a physician, his many years of service to organizations in his community, and for his remarkable lifetime of loyalty to the Kansas Chapter of Delta Upsilon, Lud has been chosen to receive the DU Distinguished Alumni Award posthumously at our annual spring event.

Honoree: Ernest C. Friesen Jr. '50

Ernie Friesen '50 came to KU from Hutchinson, Kansas, and was one of three brothers, in addition to **Hal '49** and **Wilbur '49**, to inhabit the Chapter House post-WWII. While at KU, Ernie held a remarkable number of campus and fraternity offices, including All-Student Council president and vice president, Junior Statesman Club president, Interfraternity Council secretary, Senior Men's Honor Society president, Forensic League treasurer, and DU house manager. He also served on the Union operating board, was co-captain of the swimming team, a K-Club member, a national debate champion, and cadet commander of NROTC. Ernie's involvement with undergraduate activities honed his leadership and academic skills, which served him well later in life.



Ernie earned degrees from KU and Columbia University School of Law. He began his law career in New York and worked for the U.S. Department of Justice as a trial attorney. He later turned his focus to researching and teaching judicial procedure and ultimately conducted training for more than 3,000 judges. He was a Senior Fulbright scholar studying at the University of Birmingham, England, from 1974 to 1975.

In his career of educating, consulting, and lecturing on court procedure, Ernie has authored and edited numerous publications and articles. In the 1970s, he founded the first national training program for court administrators and later founded the Whittier College School of Law where he was dean and a professor. He also held similar positions at the California Western School of Law in the 1980s and '90s.

Throughout Ernie's distinguished and remarkable career, he has traveled around the world and lectured in many countries, including Canada, Egypt, and Russia. He has trained thousands of judges from every state, in military services, and in several foreign countries. One of his colleagues, Judge William Dressel of the Eighth Judicial District of Colorado, summed up Ernie's impact on his profession, stating that "a number of state and federal organizations addressing education of judges and court administrators owe their existence or the quality of their programs to Ernie's efforts."

Ernie was nominated for the DU Distinguished Alumni Award by **Ken Higdon '48** who stated, "This modest, unassuming man has been hidden under a bushel for too long. How better does one live out our fraternity motto, Justice Our Foundation?"



RECIPIENTS

Honoree: **Edmond Q. Haggart, Ph.D. '67**



Ted Haggart '67 came to KU from Salina, Kansas, and earned a bachelor of arts degree summa cum laude in mathematics and economics in 1967. While at KU, he was a Summerfield scholar and member of Phi Beta Kappa. He later obtained a Ph.D. in economics from the University of Minnesota. In 1970-73 he was in the U.S. Navy Officer Candidate School and attained the rank of ensign and lieutenant junior grade.

Ted became an assistant professor of economics at Kansas State University and taught from 1973 to 1982. Moving

from the academic world to the private sector, he became senior vice president and investment officer at First National Bank and Trust in Salina (now Sunflower Bank) and, in 1989, moved to Union National Bank in Manhattan, rising to the position of community bank president/CEO of its successor, Commerce Bank.

The lure of Lawrence called Ted back from Wildcat Country to Jayhawk Nation in 2001, when he became president and CEO of Douglas County Bank. Among his many awards and honors, Ted was a member of Leadership Kansas in 1981 and was inducted into the Salina Central High School Mustang Hall of Fame. He served as economist and staff counsel for Senator Robert Dole and was executive director of the Kansas Council on Economic Education. He was also a member of the Kansas Bankers Association board of directors and Native Sons and Daughters of Kansas.

Along with his distinguished teaching and banking careers, Ted has been very active in community and civic organizations and is highly regarded for his economic development efforts in northeast Kansas, especially the Manhattan and Lawrence communities. He served on the board of directors and chaired both the Kansas Technology Enterprise Corporation and the Lawrence Regional Technology Corporation. He continues to be an economic development force in the region.

Ted has been active in Rotary International and president of clubs in Salina, Manhattan, and Lawrence. He chaired the United Way of Douglas County campaign in 2003-04 and has served on the board of the Lied Center and the Spencer Art Museum in Lawrence. In his spare time, Ted and his wife, Nancy, enjoy spending time with their three grown children and grandchildren. Ted still finds time for KU basketball, golf, classical music, and reading.

Whether working with the Chamber of Commerce, service organizations, arts organizations, economic development entities or representing the banking community, Ted is a diligent and selfless leader and a fine representative of Delta Upsilon Fraternity. For his years of service to country and community, and in honor of his highly successful academic and professional careers, we are proud to call Ted a DU Distinguished Alumnus.
