The Kansas Chapter of Delta Upsilon continues to ride the crest of a tremendous wave of success. As you will read from other reports, the academic performance of *both* the pledges and actives was exceptional. The Chapter continues to bring home awards. Performance is top-notch, occupancy is high, and Recruitment has been excellent. I am extremely proud of our Chapter.

One of the most significant changes I have personally witnessed in the Chapter is the increase in self-respect and respect for others. A good example occurred during summer Recruitment. I was called by a parent I know, as her son had just completed formal "rush." He was tremendously impressed with DU (and is now a member of the pledge class). The visit was well organized, the DUs involved were genuinely interested, there was no alcohol, and the visit was not a perfunctory exercise. He was made to feel a part of the Chapter from that early visit. Previously, he had only known the negative reputation of the Greek system. During visits to other houses, most members seemed superficial, uninterested, and were hung over. One of the fraternities had a member passed out on the steps with the Chapter House in disarray.

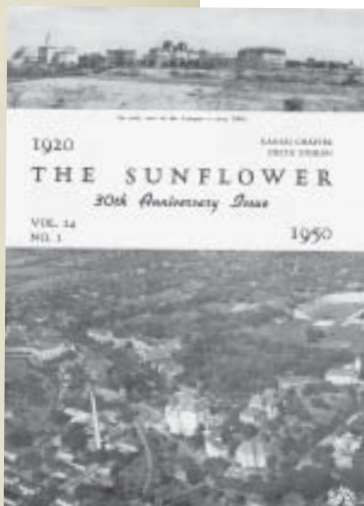
"But for the grace of God we go," I thought, but in fact, it is no mistake that the Kansas Chapter has done well. The Chapter has worked hard on improving attitudes. They are rigorously trying to shake off the general societal stigma of the Greek system and to demonstrate that being a DU is, in fact, something to be proud of. It is one thing to hear a bunch of older alumni talk about those attitudes and principles, but it is another to actually learn to live them.

Hopefully, you will not hear stories of inappropriate or rowdy behavior. However, I know of no setting where this does not happen. We are dedicated to eliminating behavior that is abusive and lacking judgment, while replacing it with dignity and respect for *all* DUs and others in society.

The alumni owe the Chapter our continued respect and support. It is a partnership that both the Chapter and alumni will continue to nurture. I urge alumni to become involved again even if only for a visit. You will be impressed.

DELTA UPSILON: MAKING AN IMPACT AT KU

Another school year has begun, and I am proud to highlight the activities and successes taking place within Kansas DU.

ACADEMICS

As you have read in past issues of *The Sunflower*, we are committed to building a premier learning community on the University of Kansas campus. Our continued emphasis on scholarship is paying tremendous dividends. Last semester the Chapter posted a 3.07 G.P.A., which is believed to be the highest academic mark ever posted by Kansas DU! In the past two years, we have increased our Chapter average by .20 and climbed 12 places in the Hill rankings, where we now sit in the top three. Nearly 60% of the Chapter earned better than a 3.0 G.P.A., and **Chris Colyer '04**, **Jon Gray '04**, **Bob Bruce '05**, **Brian Holzgraefe '05**, and **Jason Huntington '05** earned perfect 4.0s. Chris, a business administration major aspiring toward a career in investment banking, was awarded the **Keith Bunnell '46** Scholarship Award during this fall's Scholarship Dinner. **Brett Showalter '02** was recognized for having the Most Improved G.P.A. Twenty-nine other members will divide \$3,250 in awards provided by the Mom's Club based on their academic performance.

DU LEADERSHIP INSTITUTE

In July 2002, **Grant Thompson '04**, **Kyle Schafersman '04**, **Jeff Dunlap '05**, **Rod Barleen '97**, **John Esau '73**, and **Lewis Gregory '75** represented the Kansas Chapter at Delta Upsilon's Leadership Institute and Convention in Cincinnati, Ohio. More than 400 DUs representing 77 chapters, colonies, and interest groups were in attendance. The Kansas Chapter earned a Chapter Excellence Award and was a

We are proud to welcome 24 highly talented individuals into this fall's pledge class. These young men will contribute to our pursuit of excellence in the upcoming year. Within this group, there are seven legacies, including a third-generation Kansas DU. **Tyler Emery '06** follows his father **Tom Emery '57**, Uncle **Frank E. Emery '55**, and Grandfather **Frank A.C. Emery '27**.

Quality Recruitment continues to be a high priority for the Kansas Chapter, and as we continue to compile our database of top-level prospects, we recognize and greatly appreciate the personal recommendations our alumni and friends provide. This year's Recruitment effort will be lead by **Paul Gregory '05**, **Wes Osbourn '05**, and **Jason Shanker '05**. As you will clearly see, the 1952-53 Kansas DU Chapter had an outstanding year at the University of Kansas. Yet the similarities with today's Chapter are strangely familiar. Our success is clearly based on our goals and principles, which have been handed down every year since 1920. We can point to our successes in scholarship, campus activities, athletics, as well as social activities, and continue to demonstrate the position and influence of Delta Upsilon at KU. To this notion, we devote this section and review of our impressive history.

Mother Hooke was serving her twenty-second year as the official hostess of the Kansas Chapter. Mother Hooke had traveled widely and studied in Europe, and her influence on the Chapter was profound.

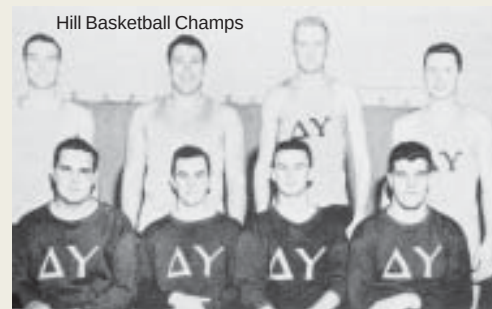
Good leadership is definitely a necessity in the Fraternity, and the Kansas Chapter had a stable of leaders at the helm. **Bob Kenney** had assumed the gavel in November '52 from past-President **Dick McCall**, and **Jay Warner** was directing the rush efforts after successful terms as vice president of his freshman class, and president of his sophomore class.

Ralph Lamb was on the executive council of Pachacamac and a member of Sigma Tau, Owl Society, Engineering Council in addition to his D.U. Treasury duties. **Gene Hall** found time to be president of Alpha Kappa Psi, the honorary business fraternity in addition to holding the rank of colonel in the Air Force ROTC. **Mark Gilman** was president of the University Players, and appeared in 12 university plays and directed another. **Bill Landess** was Group Commander in the Air Force ROTC unit besides his hard-work in campus pep rallies, social activities, Statewide activities and the Arnold Air Society. **Hubert Dye, Harold Henson, George McKemey, George Michale, and Terry Fiske** were also prominent Chapter officers.

Delta Upsilon can truly look with pride to the '52-'53 year as a year which saw D.U. brothers making outstanding records in one of Kansas University's greatest sport seasons.

In football, four D.U.'s wore the crimson and blue of K.U. and made names for themselves on the gridiron. **John Konek** (all Big Seven and honorable mention All-American), **Jerry Taylor, Merle Hodges, and Bob Alpers** are the D.U.'s who contributed heavily to K.U.'s fine record the past season.

Al Kelley, one of the returning lettermen, was the second leading scorer on the team and was placed on the Big Seven first team and gained an honorable All-American with his brother Dean. His hustle and determination helped the Jayhawks roll to the finals of the N.C.A.A.

Wes Johnson and **Wes Whitney**, both of Newton, bring the total to five D.U.'s on the Jayhawk basketball team.

In spring sports, **Jack Stonestreet**, Wichita, was a mainstay on the K.U. baseball pitching staff. Stoney had an exceptionally good record on his way to earning his third letter.

Bob Kaak, a transfer student from Purdue. Was a promising catcher and a valuable member of the 1953 baseball team.

Jim Mears, Kansas City, was on the K.U. golf team. This former Shawnee-Mission golfer had won several tournaments in and around that area.

The Hill Basketball Champions resided in the D.U. house, with a team composed of **Bob Shirley, Merle Hodges, George McKemey, Dick McCall, George Michale, Walter Folck, Brad Tate, and Don Slawson**. D.U. also saw division championships in volleyball and softball.

Delta Upsilon enjoyed another highly successful year in the area of social affairs. The highlight of the Fall season was the Annual Trophy Girl Formal, which was held at the Eldridge Hotel. Every D.U. also looked forward to the Formal Stag Dinner, held just before the Christmas holidays, and the frantic sewing of costumes and last minute decorations that marked the D.U. Two Yard Hop, acclaimed as one of the outstanding campus parties. And these are only a few of the pre-planned occasions. Added to this list could be the many spontaneous get-togethers, picnics, Coke dates, and Friday evenings at the Stables — things which go into the making of D.U. at Kansas.
