DU RECEIVES CHAPTER EXCELLENCE AWARDS

Countless hours of hard work and extra effort are paying off for the Kansas Chapter of Delta Upsilon. Now in my third year, it is difficult to contain my excitement as I witness the determination of the Chapter working toward realizing our vision for the organization. We are consistently meeting our goals of improving academic standing, furthering our presence on campus, and inspiring each other to become Total DU Men. The spring semester has been very busy, and I am happy to relate our accomplishments thus far.

ACADEMICS

The Kansas Chapter inched closer to the Chancellor's Trophy for fraternity G.P.A., posting a 2.97 mark for the fall semester. This indicates the third consecutive semester in which the Chapter average has shown steady improvement and DU is only .07 of a point from 2nd place on the Hill. Nearly 10% of the Chapter earned perfect 4.0 G.P.A.'s for the semester, including four

members of the freshman class, 38% earned a 3.25 or higher, and 60% earned better than a 3.0. In addition, our freshman class led all new member classes on campus with a 3.08 mark, with the 21 new initiates earning a staggering 3.32 G.P.A. We are continually strengthening our academic assistance program, recruiting additional faculty advisors, and extensively reorganizing our test files. We feel these accomplishments demonstrate our commitment to our mission of building a premier learning community.

According to Irene, this was "in spite of WWII." She also says that "Heinz's death results in a shattered world for me." ■ **William G. Moeckel '36** passed on to Chapter Eternal in March 2001. William was an accomplished architect, artist, and civic leader. He was 87 years old. He is survived by his wife, Elizabeth.
