The Kansas Chapter wrapped up 2002 with an exciting and productive finish. The Chapter once again established a record scholarship mark with a 3.08 G.P.A. More than 65 percent of the members earned better than a 3.0 average. We are particularly proud of our freshman pledge class, as they eclipsed the campus all-freshman men G.P.A. of 2.59 with their own 3.05 G.P.A. Plans are being developed to celebrate our success, recognize our scholars, and thank our faculty advisors with a scholarship dinner in April.



TRADITIONS *Advancing Our Values*

One of the elements that is deteriorating in society today is the understanding and passing on of traditions. Traditional family values and social traditions have often disappeared or have given way to less productive and wholesome behaviors. One function of the Greek system is to advance values and traditions that fraternities have held in esteem. Depending on the chapter and fraternity, those traditions may be productive and socially valuable, or they may be destructive and unhealthy.

Delta Upsilon is fortunate to have a rich heritage of tradition based on values that were as unusual in the 1830s as they are today. We have all learned those basic underlying principles, but sometimes have neglected to articulate them and use them in our daily lives. DU is built on the

belief that we should treat our fellow men with dignity, respect, and in a just manner. Our principles recognize that in conducting our lives, we should develop our character and foster the development of character in those around us. We continue to do this as we develop our friendships, and as we explore and embrace many aspects of culture and education.

As we work to foster a healthy and productive Chapter, the communication and articulation of tradition is critical. The young men in the Chapter can do only so much of this. It is up to the alumni to provide steady input on our principles and traditions. Without alumni guidance, Chapter tradition breaks down and young men will fill in the void, and not always in a positive manner.

GREEK AWARDS

Speaking of adding hardware to the trophy case, the Kansas Chapter was highly decorated at Greek Recognition Night on February 24. The Chapter earned third place for Most Improved Scholarship from spring 2001 to spring 2002, third highest Chapter G.P.A. for spring 2002, and was the recipient of the Overall Chapter Improvement Award. DU also received Chapter Excellence Awards for the following areas: scholarship, financial management, risk management, inter-fraternal relations, community relations, and alumni relations. The Kansas Chapter was one of only two fraternities to receive the Overall Chapter Excellence Award! In addition, **Dallas Rakestraw '03** was recognized as an Outstanding Senior.

RISK MANAGEMENT

A new risk management program has led to tremendous leaps in alcohol education. Members have been strongly encouraged to complete an online program called AlcoholEdu. This tutorial walks you through several video clips and stops periodically for individual assessment and surveys. The Chapter members who have finished the program have agreed that it is very informational and enlightening.

COMMUNITY INVOLVEMENT

In what has become an annual event, the Chapter is again sponsoring the West Hills Neighborhood Cleanup, tentatively scheduled for late April. The planned cleanup effort and barbecue provides a great opportunity to demonstrate our commitment to the community, and also allows us to socialize and build better relations with the other fraternities, sororities, and residents in our neighborhood.

As we near the new member signing day of May 4, our quest to fill the fall 2003 pledge class is in full swing.
