Recruitment

2006 DISTINGUISHED AL

HONOREE: R. DAN BOULWARE '68

Brother **R. Dan Boulware '68** has been selected for the 2006 Distinguished Alumni Award. This honor is a true testament to Dan, who continues to serve and represent Delta Upsilon with dedication, loyalty, and strength in character in his many philanthropic and leadership efforts.

Born and raised in Columbus, Kansas, Dan pledged DU in 1964 and graduated from the University of Kansas Law School in 1972. He co-founded Watkins, Boulware, Lucas & Miner LLP, a law firm that grew to 21 attorneys and later merged with Shugart, Thomson & Kilroy PC. Dan is a member of the firm's Executive Committee and is a senior trial lawyer who has served as lead counsel in many large, high-profile cases in state and federal courts. Listed as one of the best lawyers in America, his practice extends far beyond Missouri. He has represented many of the firm's corporate and individual clients in the successful defense and/or prosecution of claims, recovering, through trial and settlement, millions of dollars for clients.

Since age 35, Dan has carried an "AV" rating from Martindale-Hubbell Law Directory, the highest rating bestowed on an attorney. He was the recipient of the 1982 Lon Hocker Memorial Trial Lawyer Award given by the Missouri Bar Foundation and inducted as a fellow of the prestigious American College of Trial Lawyers in 1989. He serves as a member of the ACTL Missouri State Committee and the Samuel E. Gates Litigation Award Committee. *KC Magazine* recognized Dan as one of the Top 100 Super Lawyers in Missouri and Kansas in 2005.

Dan has been very active in civic organizations, working on fund drives for the YMCA, Young Life, the Multiple Sclerosis Society, and the Greater St. Joseph United Way. He incorporated and assisted in the organization of Creative Arts Productions, a children's theater workshop, and The Industrial Development Authority of St. Joseph, Missouri. He was the co-founder and organizer of the Rainbow Coalition, a political action group formed in 1987 to support St. Joseph Public Schools in passing a critical increase in the local school levy. Dan is past president of the St. Joseph Chapter of the KU Alumni Association and a member of the KU Greater University Fund Advisory Board. He also served as a member of the Board of Regents of Missouri Western State College.

Dan is a long-standing Sunday school teacher, deacon, and executive committee chairman for the Wyatt Park Baptist Church in St. Joseph. He is an avid golfer, sports enthusiast, and supporter of KU athletics. Dan and his wife, Dale, reside in St. Joseph, Missouri, and were the 2003 recipients of The Hope Award given by the National Multiple Sclerosis Society, Mid-America Chapter, in recognition of outstanding community and philanthropic service and leadership. They are ardent supporters of the arts in St. Joseph and are Founding Fellows of the Albrecht-Kemper Museum of Art.

In addition to his many civic, educational, and charitable roles, Dan served as a director of the Kansas DU alumni corporation, was instrumental in founding the Kansas Chapter of Delta Upsilon Educational Foundation, and actively participated in the effort to renovate and enlarge the Chapter House.

UMNI AWARD RECIPIENTS

HONOREE: KENNETH P. KOENIGS, M.D. '78

A native of Goddard, Kansas, Brother **Kenneth P. Koenigs '78** was a 6' 10" forward who played for the University of Kansas basketball team from 1974 to 1978. While playing, he would often return from a road game at 3 a.m., then be in the chemistry lab by 7:30 a.m. Such is the "stuff" this DU Brother is made of. Ken was captain of the varsity team 1976-78, won Academic All-American 1976-78, was first team Big Eight Conference 1977-78, and was the recipient of a NCAA post-graduate scholarship. In addition to putting points on the board and grabbing rebounds, Ken excelled in the classroom and was named Academic All-American. The KU athletic department annually awards the Ken Koenigs Academic Award to a deserving men's basketball scholar/athlete. Many alumni will recall him playing on the Ted Owens team that included another DU Brother and standout basketball player, **Paul Mokeski '79**. Ken was drafted in the fifth round of National Basketball Association by the Cleveland Cavaliers.

Ken graduated with a chemistry degree in 1978 and graduated from KU Medical School in 1982. He did his residency at Yale-New Haven Hospital in Connecticut and did post-graduate training at Yale School of Medicine, where he was a senior clinical instructor. Ken is a fellow in gastroenterology. Among his many honors and awards, Ken graduated Phi Beta Kappa, is a member of Alpha Omega Alpha Medical Honor Society, and has been listed in the *Best Doctors in America Northeast Region*.

Ken and his wife, Laura M. Koenigs, also a physician, reside in Springfield, Massachusetts, and continue to be stalwart supporters of KU. Ken has been a member of and served on the board of the KU Alumni Association. During the KU First campaign, Ken and Laura actively worked with the KU Endowment Association to raise funds in the northeast region and hosted an event for KU alumni and supporters in Boston. For his undergraduate accomplishments, his distinguished medical career, and his continuing loyalty to and support of the University of Kansas, we are proud to honor Ken with the 2006 Kansas DU Distinguished Alumni Award.

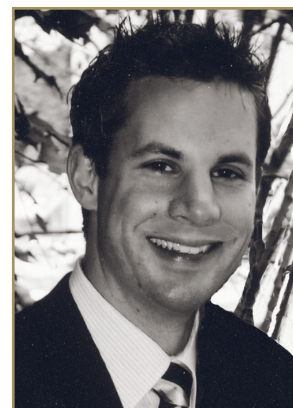
HONOREE: ROD BARLEEN '97

He has served continuously as alumni advisor and on the Alumni Corporation Board. Of the many fine and dedicated alumni who have served, Rod has perhaps the most "hands-on" contact with the undergraduate Chapter. From recruitment to finances, leadership training to behavior modification, Rod has been there, relishing the high points and dealing with the low points. Although he is one of the youngest brothers to receive the Distinguished DU Alumni Award, Rod is no less deserving. A fine DU alumnus has often said, "Example isn't the best teacher, it's the only teacher." He serves as a fine example to us all.
